**Report by Anti- Drug Cell on Inquiry on recovery of suspicious substance from Geetanshu and Piyush, BBA 2<sup>nd</sup> year students residing in the Boys hostel**

The case was brought to notice of the anti -drug cell on the 13<sup>th</sup> September, 2022. A formal meeting of the anti -drug cell regarding the matter was held on the 16<sup>th</sup> September, 2022 where the members of the anti- drug committee met with both the students (Mr. Geetanshu Bhayana, Registration No. GF202113584 – BBA 3<sup>rd</sup> Sem and Mr. Piyush Jakhar Registration No. – GF202111966, BBA 3<sup>rd</sup> Sem).

The students admitted to charges as was also mentioned in a letter that they had signed and handed over to the Chief warden the day they were caught. The students came forward with some names of other students who were involved and initiated him into these activities. In his statement to the Committee Geetanshu stated that an MBA student Jatin who was earlier a hostler and staying in New Boys Hostel provides to him. He further has been selling to some other students and handing over the sale proceed to Jatin, the present quantity recovered is also provided by Jatin. The members of the cell are actively pursuing and following up on these leads.




**Recommendations**

All the members of the cell strongly recommend strict disciplinary action be initiated against Geetanshu, who is a repeat offender with respect to possession and use of alcohol in the past too. The committee recommends a suspension for durations as deemed appropriate by Registrar and VC.

For Piyush it is recommended that he be let off with a strict warning this time and that he is aware of the consequences if he repeats such an act in the future

It was also agreed that a two-pronged approach of counseling and awareness combined with strict discipline and punishment for such cases should be followed in the future.


**DISCIPLINE-STUDENTS**
