Objectives of Memorandum of Understanding

Shoolini University founded by leading academicians, professionals and it is a young, research-focused, philanthropic university which is established in 2009. Shoolini University itself has 9 institutes inside - Faculty of Agriculture, Faculty of Applied Science and Biotechnology, Faculty of Engineering and Technology, Faculty of Management Science, Faculty of Liberal Arts and Ancient Indian Wisdom, Faculty of Science, Faculty of Legal Science, Faculty of Pharmaceutical Science, Shoolini Institute of Media and Communication. The university has consistently been ranked among India's top 100 universities (NIRF), is one of India's highest generators of patents and innovation, and matches the world's best universities in research output. A not-for-profit multi-disciplinary private university, Shoolini has a unique research and innovation-led model.

Indian Institute of Technology (IIT) Mandi is a government-funded institutions created through the act of Central Governments.

To promote and support academics and research for the development of excellence in both the institutions, the two institutions have agreed to cooperate in the following main activities:

- Exchange visits of faculty and staff for the purpose of research, teaching and consultancy with prior approval from both the institutions for a duration of up to one year. Joint supervision of postgraduate and Ph.D. students as per the norms of both the institutions.
- Permissible exchange of scientific information for academic purposes.
- Utilization of research facilities at special usage charges applicable for H.P. users.
- Training of students on facilities at both institutes subject to availability of resources.
- Joint research activities through participation in nationally and internationally funded projects.

- Organization of joint events such as seminars, workshops, conferences, training programs, etc.

1. Financial Arrangements:

2. Duration renewal:

The MoU is signed initially for **five years** at the first instance from the date of signing. Further continuance of this MoU will be subject to joint agreement and review by both parties to be undertaken before the expiry of this MoU.

3. Advertising and Publicity:

Both the institute may advertise this MoU for information of students, faculty, staff and the general public.

4. Modification of MoU:

This MoU may be modified at any time if circumstances arise which call for any alteration, subject to the approval of both parties.

5. Statutory Compliance:

This MoU solely expresses the intention of both institutions. It is agreed that it does not have a legal effect nor create any financial obligations on either institution.
