**MEMORANDUM OF UNDERSTANDING
BETWEEN

Shoolini University, India and Rohini Biocare Research Paonta Sahib (H.P.) agree to cooperate on the DBT Biotechnology Finishing School program in the area of Biopharmaceutical Technology / Nutraceutical and Food Processing based on principle of reciprocity.

This Memorandum of Understanding (MOU) encourages both the parties to participate in the Biotechnology Finishing School Program of DBT, Govt. of India for the upliftment of the technical skills of the students and to make them employable in the industry. Further, the upgradation of industry academia partnership, student's skills, curriculum upgradation, joint research hand exchange of faculty, scholars, students, academic information and materials in the belief that the research and educational process at both organizations will be enhanced and that mutual understanding between their respective employees, faculty, scholars and students will be increased by the establishment of such exchanges.

1. Both parties agree to promote the following activities based on need of partnership for Biotechnology Finishing School Program of DBT and further for deeper collaboration in academics and Research:
 - a. Defining Industry needs for skilled manpower and to formulate the curriculum of Finishing program accordingly
 - b. To impart Industry relevant knowledge to the aspirants through lectures
 - c. To impart on job training to the aspirants at the industrial establishment. Shoolini University will pay the Scholarship to the aspirants during the training period from the project.
 - d. To jointly monitor the progress and continuous feedback of the aspirants during the tenure of the program.
 - e. To further strengthen Industry Academia Partnership
 - f. Curriculum upgradation for the regular ongoing programs of the University.
 - g. Upgrading the student's skills (including undergraduate and graduate students)

- h. Exchange of staff for training purposes
 - i. Organization of joint research and consultancy programs
 - j. Organization of joint conferences
 - k. Other academic exchanges agreed to by both partners
 - l. Faculty development
2. The implementation of each specific exchange based on this MOU shall be separately negotiated and determined by both institutes. Efforts shall be made by both sides to find financial sources for carrying out the exchange programs.
 3. Nothing shall diminish the full autonomy of either institution, nor will any constraints or financial obligations be imposed by either upon the other in carrying out the MOU.
 4. This MOU is in force for five years and is subject to revision or modification by mutual agreement. It is also understood that either institution may terminate the MOU at any time, although such action will only be taken after mutual consultation in order to avoid any possible inconvenience to all parties. This MOU shall take effect from the date of the latest signature below.
