
10. Proposed outcome (Deliverables):

Hypochlorous acid formulation, ointment for frost bite and other products (Alpha ketoglutarate Oral, Alpha- ketoglutarate (12.5%) for injection.

## 11. Terms and Conditions:

- I. The total amount will be released in three installments. First installment of Rs.6.00 lakh will be released at the time of the sanction of the project. The Second installment of Rs. 3.00 lakh will be released after completion of performance milestone - I of RSQR, evaluation of work progress, submission of funds utilization certificate and Final installment of Rs 0.84 lakh will be release after completion and submission of performance milestone - II of RSQR.
