

## MOU SIGNING CEREMONY

And

Ladli Foundation Trust, New Delhi

**SHOOLINI UNIVERSITY OF BIOTECHNOLOGY AND MANAGEMENT SCIENCES** situated at Bajhol, Solan 173 229 Himachal Pradesh, a private University recognized by UGC established under Private Universities act of Himachal Pradesh **through** its Pro Vice Chancellor, **Prof. Atul Khosla** (hereinafter called as “**SHOOLINI**”), which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors and assigns of the Other Part;

AND

This Memorandum of Understanding (MOU) has been signed on this November 11, 2022 between **LADLI FOUNDATION TRUST, NEW DELHI** through its Founder and CEO **Mr. Devendra Kumar** (hereinafter called “**Ladli Foundation**”), which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors and assigns of the One Part;

### OBJECTIVES

1. Purpose and Scope. The Parties intend for this MOU to provide the foundation and structure for any and all possibly anticipated binding agreement related to social initiatives related to Human rights and various reforms.
2. The Parties shall work together in a cooperative and coordinated effort so as to bring about the achievement and fulfillment of the purpose of the MOU.
3. It is not the intent of this MOU to restrict the Parties to this Agreement from their involvement or participation with any other public or private individuals, agencies, or organizations.
4. The Parties shall mutually contribute and take part in any and all phases of the planning and development of all research-based initiatives to create awareness among masses to the fullest extent possible.
5. This MOU is not intended to create any rights, benefits, and/or trust responsibilities by or between the Parties.
6. The MOU shall in no way obligate either Party to supply funds to maintain and/or sustain.
7. This Memorandum of Understanding (MOU) encourages the exchange of academic information and materials in the belief that the research and educational processes at both

the institutions will be enhanced with the mutual understanding between their respective faculty, scholars, and students by the establishment of such exchanges.

8. The institutions agree to promote the following exchange activities based on their respective academic and educational needs:
  - a) Exchange of academic information and materials.
  - b) To foster the exchange of academic publication and scholarly information.
  - c) To organize joint research programs like seminars, conferences, and Workshop on topics of mutual interest.
  - d) Students of the university shall work on the impact assessment report of all the projects of the Ladli Foundation as assigned to them with the guidance of their respective professors.
9. To Involve the University students in all or any voluntary work being undertaken by the NGO and provide suitable internship opportunities. To make students aware about the societal and humanitarian approach.
10. Non- disclosure both the parties are bound not to disclose all or any of the information shared under the said MoU without the consent of other party.


#### **TERMS & CONDITIONS**

1. The implementation of each specific exchange based on this MOU shall be separately negotiated and determined by both the Institutions. This MOU being non-financial in nature, both parties shall be responsible to find respective financial sources for carrying out the exchange programs.
2. This Agreement shall commence upon the Effective Date, as stated above, and will continue until one year
3. Nothing shall diminish the full autonomy of either institution, nor will any constraints or financial obligations be imposed by upon the other in carrying out the MOU.
4. This MOU shall be in force for one year and is subject to revision or modification by mutual written consent. It is also understood that either institution may terminate the MOU at any time, although such action will only be taken after mutual consultation and consent to avoid any possible inconvenience to all parties. This MOU shall take effect from the date of the latest signature below.
5. Entire Agreement. The Parties acknowledge and agree that this Agreement represents the entire agreement between the Parties. If the Parties desire to change, add, or otherwise modify any terms, they shall do so in writing to be signed by both parties.
