The DelhiNCR chapter of ICF will undertake this project under 'Gift Coaching initiative' and deploy volunteer coaches amongst the members of the society. **The project will run on Pro-bono principle.**

This document describes the responsibility and expectations between *ICF Delhi NCR Chapter (Rajdhani Coaching Association (Service provider)* and *Shoolini University of Biotechnology and Management (Community partner)*,

Responsibilities and Expectations:

ICF Delhi NCR *Chapter* manages the following:

- Maintaining and implementing the Coaching program.
- Supplying Coaches from its members.
- Compliance to ICF Code of Ethics (<https://coachfederation.org/code-of-ethics>).
- ICF Delhi NCR Chapter will jointly manage the outcome of the coaching. However, it is a solemn commitment of the DelhiNCR chapter of ICF Global to deploy the most competent and resolute coaches for the project.
- The outcome of the coaching process. which is a concurrent effort, will be laid down with utmost clarity and checked through a robust process. The patterning organization can

deploy a monitoring process of its own subject to the ethical standard and confidentiality requirement of ICFGlobal.

Under this MoU, Shoolini University of Biotechnology and Management Sciences, Bajhol, PO Sultanpur, Distt. Solan – 173229 (HP), India *Community Partner Organization*, agrees to:

- Share relevant information and resources with the *ICF Delhi NCR Chapter (Subject to the conditions which will be under the Non-Disclosure Agreement (NDA) between both the parties to safeguard the IP rights of both the parties)*.
- Actively take part in the initiative, assessments, and evaluations (if any).
- Reporting the results of partnership accomplishments through determined measurements.
- Provide an organization point of contact to work with the *ICF Delhi NCR Chapter* for matters related to easing and liaising.

Time period

This MoU covers from September 2021 through May 2022. If the program duration is extended for any period, an agreed modification will be signed by the two parties.

Termination

ICF Delhi NCR Chapter may end this MoU, in whole or in part, with or without cause, if the terms and conditions of the present MOU not met.

Either of the parties have a right to end the MoU by giving a one-month notice in writing with no responsibilities or obligation, neither work nor financially.

Force Majeure

Neither party hereto shall be considered in breach hereof or in default if it fails to perform or observe any or all of the terms of this MoU resulting directly or indirectly, such as, but not limited to acts of God, Civil or Military authority, acts of Government, acts of Public Enemy, war, riots, explosion, earthquake, flood, storm, lightning strike, Pandemic, etc. (need to re word) its fi

Arbitration.

In case of any dispute/s arising out of or in connection with this MoU or from the breach of this MoU or its interpretation of any nature arising between the parties with respect to this MoU, the Parties shall first meet and exert their best efforts to reach an amicable settlement within a period of 15 days from the date of the Parties first meeting to resolve the same.

Communication

Public Communication related to the MoU will be discussed between the parties to arrive at a mutual consent.

The present MoU shall come into action upon signature. It shall remain valid until the parties have fulfilled all their mutual obligations hereunder or ended as written above.
